

EXCISE TAX CHANGES ARE IN EFFECT

Per the Washington State Legislature, the Department of Revenue is required to adjust the selling price thresholds for real estate excise tax every fourth year. Effective January 1, 2023, Washington's real estate excise taxes tier system changed, increasing each sales price tier by \$25,000:

^{*}Municipalities of Darrington, Eatonville, Skykomish and Wilkeson have a lower tax rate of .25 percent.
